## **Pastor's Report**

Dear Central Baptist Church Family,

I was called to CBC in 2015 with an official start date of November 16th. A very special day that I hold dear as a new chapter in my life began. It is with great honor and humility that I begin my annual report with thanksgiving to God for this wonderful opportunity to share my faith and life with a congregation that goes beyond the meaning of hospitality and Christ's command to love God and neighbor. I have witnessed such great faith, compassion, caring and love from our church family not only to me personally but to my wife, Jennifer and many members of my family especially my four boys who have had the pleasure to join us for worship, community dinner celebrations, Christmas service and more.

As a retired law enforcement Detective I can attest to the truth of "brotherhood/sisterhood" among those you work alongside in the law enforcement arena. This is and remains (with retirees) a close-knit group of individuals who support and care for one another more than what I have witnessed in other professions including the ministry. Before my call to CBC I spent eight years in another parish, followed by five challenging yet such rewarding years as Director of Pastoral Care for a large Home Health Care and Hospice organization, and in both I cherish loving memories. However what I have discovered at CBC is a rare gift of camaraderie, fellowship and a unique aptitude of sharing Christ's teaching to love all people. Oftentimes I wander into our church sanctuary alone and discover a peaceful serene setting to pray, meditate or simply be still. It warms my heart each time I enter into our beautiful sanctuary alone or during church services with this wonderful community of fellow believers.

My initiation into this pastoral role immediately began with the busy Advent Season, Christmas, Lent and Easter. During that time we continued with Bible Study moving it to the evening allowing more people to attend, began a Book group, started an Ad Hoc committee titled "The Dugout Committee" to get the basement kitchen and hall up to date and this remains a work in progress. I have shared many visits with congregants getting to know most of you whether in the office, our sanctuary, in the hospital, at the bedside of a shut-in or ill person or through a hospital pastoral visit. All of these venues allowed me to further get to know many of you on a more personal level and vice-versa for you to get to know me.

**Christian Education** bolstered our Lenten ministry offering soup and sanctuary to everyone. The Wednesday event was well attended with parishioners sharing their recipes for soup and fellowship along with quiet time, readings, and music in our sanctuary. CE personnel introduced me to our Senior Center and many Jamestown residents. I met several times with a small group and CE ran with a common desire from the group to educate our seniors by inaugurating a succession of forums entitled, "Umbrella Series." The forums became quite popular and will take a summer hiatus only to begin again in the fall bringing in much enthusiasm from parishioners and residents alike hearing different speakers to guide, inform, educate, etc. on many topics. Sunday school has been a challenging topic within the CE committee. The challenge was brainstorming how CBC could attract young families with hopes of growing our program. Many ideas have spouted and it is with faith and determination that I believe we will be once more smiling at little faces as they join us

on Sunday. Hats off to this small number of parishioners with great ideas and loads of energy. Thanks Christian Education!

**Trustees** worked diligently and tirelessly taking care of our finances, building, grounds and more. They jumped headfirst into our stewardship program with gusto and put together our 2016 budget. For most all churches this is a trying feat to balance any church budget. Thanks to all our Trustees who have done so much looking forward to a new fiscal year on the heels of a demanding year without a pastor. I personally am honored to 'show off' our lovely church with many visitors expressing how beautifully kept everything is especially our sanctuary. Thanks Trustees!

As a new pastor I cannot begin to say how appreciated I feel knowing our angelic **Shepherds** were out visiting people I had not even met or know were homebound, in the hospital or needing pastoral care. Each of them unbeknownst to many congregants I imagine, continue to visit and minister to many people in our church. Thank you Shepherds!

A **Deacon** role is oftentimes very demanding with keeping the congregation alive spiritually, assisting the pastor with Christmas, Easter, Weddings, Memorial Services and weekly worship services. However I give kudos to our Deacons for 'holding down the fort' in absence of a pastor. Coming on board it was mentioned to me by many congregants what a wonderful job our Deacons had done for this church in the amount of time, energy, and going well beyond the call to make sure everything was running smoothly. It goes without saying I believe to everyone how important this committee is and the great job they have done. Thank you Deacons!

**Nominating** may not have the arduous task of meeting monthly however with many parishioners finishing their terms their end of the year task was demanding. Yet they would meet weekly and have filled most all of the open spots for 2016-2017. Great job. Well done. Thank you Nominating!

**Pastoral relations** was instrumental with our employees absent the pastor but fulfilled their roles diligently helping to make certain if any issues came to light they would be ready to move in to assist. Hopefully their role this year will be minimal and just like an insurance policy we can be sure all of us have an advocate if necessary. Thank you Pastoral Relations!

**Pastoral Search Committee** was kind to me. They spent many hours interviewing, watching sermons, attending church services outside CBC and met on a weekly basis holding at bay all candidates until I was interviewed!! On a very serious note any search committee has a demanding role with countless hours away from family and their personal lives. It was this committee also that allowed me to witness what type of church I would be pastoring witnessing their hospitality, compassion, and making me feel at ease during our times together. A special bonus for me and this community of faith at CBC and the people of Jamestown was meeting forming a close-knit bond with our neighboring clergy, Saint Matthew Episcopal Rector, Kevin Lloyd and Saint Mark Catholic Priest, Ron Brassard. Formalizing this bond into a faithful covenant signed during our Good Friday ecumenical service cemented our friendship and offered Jamestown residents to witness something out of the ordinary and wonderful for all involved. Our solidarity offers personal support and wellbeing for the roles we have as clergy and opens avenues of benevolence to all of Jamestown.

# **Clerk's Report**

#### 2014-2015 Annual Meeting – May 17, 2015

Moderator Deb Nordstrom called the meeting to order at 10:30 a.m.

Before proceeding, the congregation remembered Don Richter, who died last September, with a moment of silence.

Old Business: There was none.

New Business:

Deb proposed accepting all the reports as printed in the 2015-2016 Annual Reports. It was so moved, seconded, and passed.

Deb recognized Todd Merrill, chair of the Board of Trustees, who presented the proposed 2015-2016 budget. Todd expressed thanks to everyone for CBC support.

He reviewed the ensuing discussion. Points of interest and/or concern in the budget include the following: \*Savings are up, because we are not currently paying a full-time pastor. \*The Board has moved CD savings to ABCORI Investment, which provides a good return, and is re-investing quarterly interest until the money is needed for the general fund. This investment money is completely liquid. \*Concern that pledges are down \$18,000. \*Deficit projected to be \$5,926. Concerns expressed in discussion of the budget: The discussion focused almost exclusively on the search for a new pastor, the biggest question being whether CBC needs and can afford a full-time pastor Pam Carr reminded the group that Kathryn Palen's salary had to be cut. John Andrews remarked that part-time invariably turns into full-time, so to hire a part-time pastor would not be straightforward. Todd Merrill reported that he recently e-mailed Kathryn Palen to ask her about the church's pastoral needs. She was "shocked" that we might consider a part-time position. The only question, she says, is whether we can afford it.

Barbara Haskell from the Search Committee said that advertising for a part-time pastor severely limits the pool of good candidates. (Someone) reported that Tom Wiles of ABCORI says Kathryn Palen's compensation was "about right." After further discussion the budget was approved.

Deb commended the trustees for their work on the budget. A motion was made, seconded, and passed to approve the proposed 2015-2016 budget.

Deb asked for consideration of the Nominating Committee's slate of officers. A motion was made, seconded, and passed to accept the nominations.

The meeting adjourned at 10:59 a.m.

#### CONGREGATION BUSINESS MEETING - October 25, 2015

Moderator Deb Nordstrom called the meeting to order at 11:05 A.M.

Teresa Murray led the assembly in prayer.

John Andrews made the motion "to call Kurt Satherlie to pastor Central Baptist Church: The motion was seconded (by several people simultaneously). It was passed unanimously by voice vote.' A further motion was made and seconded and passed unanimously to thank the Search Committee for more than a year of hard work: Matt Bolles, Chair, Dave Dolce, Cheryl Grelle, Barbara Haskell, and Patti Pereira. Dave Dolce thanked Matt for leading the group.

Deb Nordstrom announced that next steps include getting the contract ready. Rev. Satherlie will be in place starting Monday, November 16. His first Sunday service will be November 22, with a formal installation to be determined. Suggestions made for helping Rev. Satherlie: \*Contact him about possible rental properties. \*Paint and recarpet the pastor's office. \*Encourage him to join the choir!

Jill Dolce thanked Deb Nordstrom for keeping the pulpit filled for well over a year.

The moderator adjourned the meeting at 11:15.

## Search Committee/Pastoral and Staff Relations Annual Report

With the resignation of Reverend Kathryn Palen in the fall of 2014, the Search Committee was formed to take the necessary steps to secure a new pastor. The committee began work in early November, 2014.

After initial meetings with the Executive Minister of ABCORI and our own Executive Committee, we developed a clear path forward which included a congregation-wide survey, an open forum with the congregation, and the formulation of a CBC Self-Study document. The survey and forum informed us of the qualities most strongly desired in a new pastor and our priorities as a church. The resulting self-study provided our pastor candidates with a clear sense of who we are as a congregation and a community.

A very long list of resumes was reviewed and evaluated in light of our congregation's priorities, resulting in a short list of highly regarded candidates. We engaged each one in conversation, listened to sermons both in person and recorded, and eventually conducted four interviews. The Reverend Kurt Satherlie emerged from that process as the candidate who best embodied the personal qualities desired by our congregation, and most amply demonstrated the necessary experience and qualifications to ensure a bright future for CBC. The call to Reverend Satherlie was unanimously approved by a vote of the congregation on October 25, 2015, and he has served exceptionally well since.

Our committee has served as Pastoral and Staff Relations since that time, and we have met with the pastor from time to time to ensure a smooth transition into his leadership role in our community of faith.

## **Board of Christian Education Annual Report**

The first event of the new year was a Game Night with 20 folk of all ages, playing mental and physical games and doing puzzles, finishing with popcorn, pizza and soda - a great fun night for grandparents, children and parents.

The committee put together the results of a survey of the interests of the congregation. We have used some of the topics and there are lots more.

In August the Sunday School rooms were thoroughly cleaned by Pam Bush, thank you very much. The nursery was given special attention with a purpose built changing table, thanks to Todd Merrill, furniture was put in place and ready for little ones, we heard there might be one or two. We had a student babysit full time for a few weeks, but no one came, so we covered with volunteers until Palm Sunday. Kurt, after careful consideration, suggested we have a family service on Easter and welcome little ones of all sizes to the church service, he would not mind the noise at all!! There were some little ones at the service and all was well. They say cleanliness is next to Godliness and we were all on board to keep the damp down, the mold out and the mice at bay and succeeded most of the time!!

The Sunday School curriculum was reviewed, accepted and ordered as needed. Kathleen Williams was happy with the material and taught it this year. During Welcoming Sunday and enjoying generous servings of Sunday Sundaes the church folk were able to get acquainted with the lessons on display in Clarke Hall. After Kurt arrived he and Kathleen met often to insure that through the coordinated effort of their mutual educational goals, CBC was best served.

Two dates were set in Sept. and Oct. for the new season of the Food For Thought group. The dates turned out to be on very busy weekends and no one was able to come, so the committee tabled these events for the present.

Oct.4, 2016 we had a forum on Suicide presented by Denise Panichas, Executive Director of Samaritans of R.I. We are called a Bridge Community and people come here to jump off the Jamestown Bridge. And at the time this forum was planned our area had been hard hit with suicide it was well attended and a very sobering and informative subject.

It is a real pleasure to have our new minister aboard and attending our meetings with his input that is so helpful. Already he has led a book study on The Shack by William P. Young and met with enthusiasm. He joined us with a Movie night and all enjoyed The Ultimate Gift. During Lent we had 7-20 people come for soup and open sanctuary from 11:30am-1pm every Wed. Kurt was a strong supporter of the program. Thanks to all who made music, did worship offerings, made soup and greeted. This was a meaningful experience for all participants during this contemplative time of Lent.

Patti Pereira introduced the church mouse and now he seems to be gone. Maybe he will come for a surprise visit one of these days!!

We will end this year with the Elder "Umbrella" Series. We were planning these forums for our church and Kurt arrived and said we must think big. This was a big subject and very timely. He has been involved in Hospice and wanted the Ecumenical movement in Jamestown to get up and running. He was sure the clergy would want to help. The Senior Center was just getting going and Ellen Vietri and I had been talking about best way to get the word out as to how Elders want to be treated during end of life issues, and where to live long term, in home, nursing home, assisted living, so we thought big and here is the result. Jamestown is a great place to live and lots of people do want to help the elderly live at home as long as possible. The current forums are pretty local and there are 5 or 6 more that are possible, but they have to wait for the fall. The list of forums until the end of May are: Meet the clergy and hear about the ecumenical movement and how to help the elderly. Ellen Vietri, Senior Center Coordinator and Executive Director of the Friends of Jamestown Seniors shares her hopes for the elders and activities offered at or through the Senior Center in Jamestown. Sue Jameson, Director of Development for South County Home Health Care will address the variety of issues regarding elder care in the area. Fire Chief Bryer and Nancy Beyer, EMS and team will enlighten us on how the department helps the elderly and new information making their services more helpful in emergencies. Detective Derek Carlino from Police Department will provide information on aspects of their services that help keep the elderly safe. and finally Dr. Carla Vaccaro M.D. from the Jamestown Family Practice will share her knowledge of how all of us can have the most informative and satisfactory visit to the Dr. and why it is important to have a General Practitioner. The fall topics could be: hospice, falls, elder law, financial planning, electronic scanning targeting the elderly, undertaker.

Attention should be given to other Christian Education sessions that happen here at CBC independent of our committee. They provide a variety of stimulating experiences to all. They include, the Guys Book Group on Saturday mornings, the ongoing Bible Study, the Walking Party, with the only free gym in town!, the Financial Peace University class, and the wonderful choir, led by Norman Newberry that adds so much to our Sunday morning worship service.
